# ISTRC Call for Conference Grants, Winter 2020

For conferences occurring between November 1, 2020 – July 31, 2021

Call publication: 4.11.2020

Final submission: 1.1.2021

## **Background**

The Israeli Smart Transportation Research Center (ISTRC) at the Technion, in collaboration with Bar-Ilan University, was established jointly by the Smart Mobility initiative in Israel's Prime Minister's Office, and the Council for Higher Education. The aim is to encourage research and development, entrepreneurship and industry in the field of smart mobility in Israel. #### **ISTRC Vision**

**The vision** of the Israeli Smart Transportation Research Center is to unite the academic and R&D community and various stakeholders to initiate and leverage Interdisciplinary and Intersectoral research activities that would contribute to smart, efficient, and green transportation, and position Israel as a world leader in the field.

For this purpose, we define the **Vision of Zero Transportation Externalities** in three dimensions: Zero casualties, Zero delays, and Zero environmental harm.

- **Zero casualties:** Generating a safe, resilient and forgiving system that will optimally respond to safety and security failures while considering all road users (mixed traffic, vehicles, non-motorized and new modes, both automatic and manual), with zero fatalities and serious injuries, and a development and implication of cutting edge technologies and other means in the field of automation and connectivity.
- **Zero delays:** Generating an efficient and equitable transportation system to ensure optimal level of service that is tailored to individuals' mobility needs, while maintaining the needs of all. A system based on Transit Oriented Development, environmental friendly land use planning, and Mobility as a Service, that optimally reflects the inherent opportunities of motorized and non-motorized transport modes, public and shared transportation, and in various levels of automation.
- **Zero environmental harm:** Preventing all types of emissions, noise, and other environmental externalities by developing and adopting clean and renewable energies











for energy conservation and the promotion of sustainable transport modes and behavior.

The center collaborates with all academic institutes and researchers in Israel to promote cutting edge research and insights as well as empower and develop human capital in the field.

As Smart Transportation is interdisciplinary and multidisciplinary in nature, ISTRC encourages students and researchers from different fields and academic departments to promote ideas and research in this field.

## **Objectives of this Call:**

Aiming to generate cutting edge knowledge and insights, as well as empower and develop human capital in the Smart Transportation domain, the center initiates the Call for Conferences, to encourage students and young researchers to present at international conferences and empower the student by:

- Get exposed to new research in the field
- Establish professional network
- Represents the Israeli Smart Transportation research in the global professional community.

## **Funding**

The ISTRC will publish Call for Conference grants twice a year. This is the 1<sup>st</sup> Call for the current academic year.

This Call will fund participation in conferences that will be held between November 1<sup>st</sup> 2020 and July 31<sup>st</sup> 2021.

#### Funding opportunities:

- Virtual conferences ISTRC will fund conference registration fees.
- Physical attendance in conferences ISTRC grant will contribute a lump-sum covering the conference fees and travel expenditures according to the conference location:
  - Conferences in Europe: up to 7,000 NIS
  - Conferences in America, Asia and Oceania: up to 10,000 NIS

ISTRC Conference grants do not necessarily cover all expenses related to the conference participation, it is a contribution to the participation fees and the overall travel, accommodation, and other expenses of the grantee.

Payment of the grant is subject to proof of participation in the conference as well as submission of a conference report following the conference.











## Eligibility criteria

- Student (at all levels) or young researcher (up to one year after PhD), whose research is within the scope of smart transportation and who submitted an article for an international conference.
- Applicant should be active / registered student or active young researcher fellow while applying to the conference grant. The conference should take place no later than nine months after graduating.
- Without derogating from the above, receiving the conference grant after completing studies / fellowship is subject to the academic institute approval.
- The applicant shall make an oral/poster presentation at the conference in question and shall be listed in the official event/conference program. Receiving the grant is subject to presenting in the conference
- The applicant should be the first author on the paper submitted to the conference. (In case participation submission was not yet submitted or sent but not yet answered, you may apply to this call, as long as the conference will be held until July 2021).
- Funding is for the conference requested only. It cannot be transfer for another conference or another date.

## How to apply?

Applications should be submitted through the relevant scholarship coordinator in your academic institute.

#### **Submission by January 1, 2021**

#### **Specifications for submission:**

- Full application will be sent in **one PDF file.**
- Conference grant applications should be written in English.
- Full application should include:
  - 1. 1st page:
    - Full name of student, ID number, e-mail address, current study level (Bachelor, Master, PhD, young researcher).
    - Institute name, Faculty/department.
    - Name and e-mail address of supervisor(s).
    - Name and date of the conference.
  - 2. Paper/ presentation/ poster title, panel title (if available), and the abstract of the paper.
  - 3. Evidence of conference paper acceptance (In case participation application was not submitted yet or submitted but not yet answered, you may apply to the call, as long as the conference will be held until 31.7.2021, and declare the status of your application)
  - 4. CV (including academic and research achievements, as publications, conference participation, awards etc.)











- 5. Research progress report (up to one page)
- 6. Letter of recommendation from the supervisor.
- 7. Amount of the grant requested in NIS based on:
  - Conference participation fees (including receipt, if already paid or print screen from the conference website specifying the fee) for virtual conferences.
  - Conference fees and Travel expenditure in case of "physical" conference, based upon the conference location (see above).
- The submission is done by e-mail to <a href="istrc@technion.ac.il">istrc@technion.ac.il</a>. In the email subject please mention: ISTRC Call for Conference Grant Winter 2020 \_ Last name of the student
- Applications must include all the above items. Incomplete applications or applications received after the deadline will not be reviewed.
- Following the submission of an application, further details and clarifications about the conference may be required from the student to assist with the evaluation of the application.
- In case of conference cancellation, participation cancellation, modification of the conference dates or configuration (virtual / physical), please contact us immediately. ISTRC reserve the right to cancel, modify or postpone the grant, in case of a change in the proposal terms.

## Assessment of proposals and results

Eligible proposals will be reviewed by a review committee established by ISTRC.

#### **Assessment criteria:**

- 1. **Relevance of the paper and conference** to smart transportation and the potential to promote the center's vision of "Zero Transportation Externalities".
- 2. Importance of the conference.
- 3. Supervisor recommendation.
- 4. Academic achievements of the candidate.

ISTRC will publish winners and supervisor names, as well as the presentation title and conference name with link in ISTRC website and publications.

## Reporting

## **Academic reporting**

- The conference presentation/ poster will include <u>acknowledgement</u> of ISTRC.
- The grantee will write short conference report (up to two pages) of his/her impression from the conference and recommendations for future candidates. The report should be signed by











the supervisor and sent within 30 days after the conference to: <u>istrc@technion.ac.il</u>. The report will be published on ISTRC website.

• All publications generated from the research will include <u>acknowledgment of ISTRC funding</u>.

## **Financial reporting**

The academic institute will receive budget commitment letter allowing the institute to allocate the grant payment to the student.

The grant sum will be in NIS, based on the conference registration fees indication or the travel allowance (and no more than the sum approved in the winning announcement).

ISTRC is working under the terms and conditions of the Council for Higher Education Call. According to The Planning and Budgeting Committee (PBC), no institutional overhead will be charged from this grant.

The grant will be allocated to the academic institute after receiving:

- Payment execution report signed by the finance manager of the academic institute, no later than 10.10.2021.
- Participation approval, including the grantee name and presentation title on the conference agenda.
- Academic report from the conference (up to two pages) signed by the student supervisor.
